Our second keynote speaker Carla Ware, NSW Audit Office First Nations Performance Audit Leader, will share her experiences gained in the position of designing and leading performance audits on issues impacting First Nations communities, as well as any insights into engaging difficult to reach communities.

Also included in the COMPACT program is panel discussion made up of four performance auditors from around the country highlighting the risks and benefits they found when engaging with end-users in an audit.

Effective Engagement with Children and Young People

She has an extensive background in education, child protection, Indigenous affairs, and suicide postvention. Her experience includes senior executive roles across state and federal governments, and the non-government sector.

As Commissioner, Jacqueline has a statutory responsibility to monitor, protect and advocate for the rights and wellbeing of all Western Australian children and young people. A crucial function of the Commissioner is to consult with children and young people, prioritising the needs and interests of Aboriginal children and young people, as well as those from vulnerable and disadvantaged backgrounds, to address issues that directly impact their lives. The Commissioner is committed to strengthening the systems that improve opportunities available to all children and young people. She firmly believes that all young people have a right to be heard, and actively works to foster a heightened level of understanding and engagement in matters that affect our children and young people, giving them a stronger voice and advocating for their needs.

Integrating Indigenous Knowledge: NSW Audit Office approach to First Nations

She has extensive public sector experience, including as Acting Deputy Ombudsman in the Aboriginal Engagement and Programs division, and with the Department of Juvenile Justice. Since Carla's appointment as the first dedicated First Nations Performance Audit Leader at the Audit Office of New South Wales, she has led performance audits important to and impacting First Nations communities with an emphasis on self-determination and people-centric practice. Carla also provides advice and support across other audits where First Nations issues are a cross-cutting consideration, and across the office more broadly on engagement and capability uplift in this space.
